August 31st, 2023

The Board of County Commissioners of Clark County, Indiana met in Regular Session on August 31st, 2023, at 5:00 p.m. in Room 103, Clark County Government Building, in Jeffersonville, Indiana.

Present at the meeting were Commissioners – Connie Sellers and Jack Coffman, County Attorney R. Scott Lewis, County Engineer Brian Dixon, Commissioners’ Assistant Sabrina Corbin, Auditor Danny Yost. Commissioner President Bryan Glover was absent.

Approval of the Minutes

D. Sheriff: The current jail population is 463 inmates, 60 are federal inmates.




