

REGULAR MEETING
CLARK COUNTY BOARD OF COMMISSIONERS
May 8, 2025

The Board of County Commissioners of Clark County, Indiana met in Regular Session on May 8, 2025, at 5:00 p.m. in Room 103, Clark County Government Building, in Jeffersonville, Indiana.

Present at the meeting were Commissioners – Bryan Glover, Connie Sellers, Attorney Scott Lewis, Commissioners’ Assistant Sabrina Corbin and Auditor Danny Yost.

The Pledge of Allegiance was led by Commissioner Bryan Glover. Prayer was led by Commissioner Bryan Glover.

Approval of the Minutes

Commissioner Sellers motioned to approve the April 24, 2025 Regular Meeting Minutes. Commissioner Glover seconded. Motion approved 2-0.

Danny Yost presented the claims and payroll for May 8, 2025. Commissioner Sellers motioned to approve the claims and payroll. Commissioner Glover seconded. Motion approved 2-0.

Commissioner Glover asked for any amendments to the agenda if not he would entertain a motion to approve. Commissioner Sellers motioned to approve the agenda as presented. Commissioner Glover seconded. Motion approved 2-0.

I. Public Comments:

Kelly Khuri- Kelly came to the Commissioner to speak about Semis coming down Charlestown Pike and Salem Noble Road. She stated they are turning onto Salem Noble Road and getting hung up on the railroad track. Kelly also wanted the Commissioners to speak to the post office about putting the mailbox on Salem Noble on the other side of the street. Commissioner Glover asked Major Mobley to share this with his team regarding the semi-truck being hung up on Salem Noble Road.

II. New Business:

- A.** John Launius and Melissa Sprigler, One Southern Indiana, presented One Southern Indiana Annual Review and Financial Request. One Southern Indiana primary functions are new business attractions, existing business expansion and existing business retention. They updated the Commissioners on all the new partnerships and programs. One Southern Indiana has brought in 1,675 jobs over the year and around \$1,084,756,218 in capital investments. One Southern Indiana is asking for \$15,000 which is the same as they have received before.
- B.** Brian Dixon, County Engineer, presented Perry Crossing and CR-403 Bid Award. MAC Construction was the apparent low bid in the amount of \$541,265.00 and submitted all the required documents needed for the project. Brian Dixon, County Engineer, recommends awarding the bid to MAC Construction. Commissioner Sellers motions to award the bid to MAC Construction in the amount of \$541,265.00 for Perry Crossing and CR-403. Commissioner Glover seconded. Motion approved 2-0.
- C.** Scott Lewis, County Attorney presented Nuisance Animal Services- Wildlife Removal Management Contract. This is an annual contract that the Clark-Floyd Landfill uses. This runs from May 1, 2025 to April 30, 2026. The total contract for the year is \$7,200 with Nuisance Animal Services. This would be paid from the Landfills funds. Commissioner Sellers motions to approve the contract with Nuisance Animal Services in the amount \$7,200 and to be paid out of the Landfill funds. Commissioner Glover seconded. Motion approved 2-0.
- D.** Sabrina Corbin, Commissioners' Assistant, presented the New Director Construction Quote for the Records Office. Recorder, Steve Gil, Recorder, requested a security wall, window and door for their office. This would be coming from the building improvement fund. Commissioner Sellers motions to approve the quote with New Direction in the amount of \$17,781.55 for the security wall, window, and door for the Records Office. Commissioner Glover seconded. 2-0

- E.** Scott Lewis, County Attorney presented the Petition to cancel property taxes assessed against real property owned by the City of Jeffersonville. These are all properties that the City of Jeffersonville acquired. Commissioner Sellers motion to approve the cancel property taxes assessed against real property owned by the City of Jeffersonville. Commissioner Glover seconded. Motion approved 2-0

III. Old Business: None

Reports:

- A. Auditor:** Danny Yost, Auditor, enters the Treasures Report into the record. Commissioner Sellers motions to approve the Treasures Report into the record. Commissioner Glover seconded. Motion approved 2-0.
He also stated Angela Noonan was leaving to go to Probation and he hired in someone new.

- B. Attorney:** None.

- C. Highway Department:** Brian Dixon, County Engineer stated Community Crossing money will be paying half of the Perry Crossing and CR-403 Project. He also stated Lance Court material are there but they have been unable to start due to the weather. He has stayed in contact with the property owners who have voiced some concern but he is staying in contact with them. He states that for the Stacy Road project it has been delayed due to weather. Appleleaf has significant blockage under the bridge and he has reached out to Dan Christiani Company for some help. Commissioner Glover asked where the County is at for RFPs for Bethany and CR-403. Brian Dixon stated he reached out to INDOT to allow him to get RFPs sent out. INDOT is supposed to get something to Brian Dixon to answer if they are going to help with funding. He stated that the highway department has put signage warning about the intersection and is removing vegetation. Commissioner Glover also asked him to look into the stop sign to see if it is ours or the City of Charlestown's to see if we can get it moved up.


