ORDINANCE NO. <u>26</u>-2024

AN ORDINANCE AMENDING ARTICLE 6, SECTION 6-2 OF ORDINANCE NO. 71983 (THE CLARK COUNTY TRAFFIC CONTROL ORDINANCE) IN ORDER TO ESTABLISH AUTHORITY FOR THE INSTALLATION AND ENFORCEMENT OF STOP SIGNS AT A CERTAIN INTERSECTION

WHEREAS, the Board of Commissioners of Clark County, Indiana (the "Board"), is the executive body of Clark County government pursuant to the provisions of Ind. Code § 36-2-2-2; and,

WHEREAS, the Board is also the legislative body of Clark County government pursuant to the provisions of Ind. Code § 36-1-2-9; and

WHEREAS, the Board has previously passed and adopted Ordinance 7-1983 entitled "The Clark County Traffic Control Ordinance, which said Ordinance has been amended from time-to time; and,

WHEREAS, upon recommendation of the Clark County Engineer, the Board now finds it to be appropriate and necessary to again amend The Clark County Traffic Control Ordinance in order to establish authority for the installation and enforcement of stop signs at the intersection of public streets in the unincorporated territory of Clark County that are more fully described in this Ordnance, and the Board adopts this Ordinance for such purposes.

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE BOARD OF CLARK COUNTY COMMISSIONERS, AS FOLLOWS:

- 1. That Article 6, Section 6-2 of Ordinance NO. 7-1983 is hereby amended to establish authority for the installation and enforcement of stop signs and the creation of a multi-stop intersection at the following intersection located in Clark County, Indiana:
 - a. Four-Way Stop at the Intersection of Charlestown-Bethlehem Road and Bull Creek Road.
- 2. All other terms and provisions of Ordinance No. 7-1983, as previously amended, shall remain in full force and effect.
- 3. That this Ordinance shall be effective upon final passage and approval by the Board of Commissioners.

Subject: Additional Stop Sign

Mr. Ed Howard, is a resident who lives at 126 River Road East and President of the Bushman's area development. He represents the residents of Bushman's and is requesting two stop signs be added to the Bull Creek Road and Charlestown Bethlehem Road intersection. Presently, there are existing stop signs on Charlestown Bethlehem Road, but no stop signs on Bull Creek Road.

Corn growing in the fields adjacent to the intersection make it very difficult to see vehicles as they approach the intersection. Some residents of Bushman's have experienced vehicles running through the stop signs and causing accidents. The sight distance at the intersection is an issue and adding stop signs should help with the overall safety of the intersection.

I recommend we add the two requested stop signs.
