January 2, 2025

The Board of County Commissioners of Clark County, Indiana met in Regular Session on January 2, 2025, at 5:00 p.m. in Room 103, Clark County Government Building, in Jeffersonville, Indiana.

Present at the meeting were Commissioners – Bryan Glover, Jack Coffman and Connie Sellers, Attorney Scott Lewis, Auditor Danny Yost.

Auditor, Danny Yost opened up the floor for nomination for President of the Commissioners. Commissioner Connie Sellers nominated Bryan Glover. Commissioner Coffman motioned to approve Bryan Glover as President. Commissioner Sellers seconded. Motion Approved 3-0

Commissioner Glover opened up the floor for Vice President of the County Commissioners. Commissioner Seller nominated Jack Coffman for Vice President. Commissioner Sellers motioned to approve Jack Coffman as Vice President. Commissioner Glover seconded. Motion Approved 3-0

- A.** Attorney, Scott Lewis, presented an Ordinance establishing the 2024-2025 Emergency Court Interpreter Grant Fund. Tom Lowe, Court Administrator was there to speak regarding the fund. C. Highway Department: Brian Dixon, County Engineer present an update on the Highway Department. He stated that is a pretty big snow storm coming and that the Highway department have been out brining roads and preparing for that. The gradall has been out of service for awhile and he stated they are waiting on the part. The company will bring it down. He also stated in the progress of The Willinger Lane Bridge, they discovered a water and gas line that were not on the original documentation. He stated the water line was active. He stated with that issue now they have to push the asphalt back and that will not get done till March 2025. Brian's last subject is Stacy Road/403. He stated that this will be pushed back and will not be finished till around December 2025. INDOT will have to approve that. He stated that MAC is asking for addition money in the amount of \$43, 3802.57 due to asbestos issue. He will get more information to the Commissioners.

D. Sheriff: Major Nick Mobley stated that the current jail population is 450 and 33 are Federal Inmates.




