ORDINANCE NO. 15 -2019

AN ORDINANCE AMENDING ORDINANCE NO. 15-2016  
CONCERNING PERMITS FEE SCHEDULE

**WHEREAS**, the Board of Commissioners of Clark County, Indiana (the "Board"), is the executive body of Clark County government pursuant to the provisions of Ind. Code § 36-2-2-2; and,

**WHEREAS**, the Board is also the legislative body of Clark County government pursuant to the provisions of Ind. Code § 36-1-2-9; and

**WHEREAS**, the Board previously adopted Ordinance No. 15-2016, which said Ordinance established certain rules and regulations pertaining to road cut permits and also established a Permits Fee Schedule.

**WHEREAS**, the Board now finds it necessary to update and amend the said Permits Fee Schedule in said Ordinance and said Permits Fee Schedule shall be rescinded, amended and replaced in its entirety.

**NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE CLARK COUNTY COMMISSIONERS, AS FOLLOWS:**

1. That the Permits Fee Schedule established in Ordinance No. 15-2016 is hereby rescinded, amended and replaced in its entirety by the new Permits Fee Schedule which is attached hereby as **Exhibit "A"**.
2. That no fines and penalties are being established, amended, rescinded or replaced by this Amendment.
3. That all other terms and provisions of Ordinance No. 15-2016 shall remain in full force and effect.
4. Effective Date: This Ordinance shall be in full force and effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of the Board.

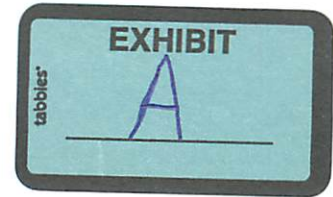

## Permits Fee Schedule



### CONSTRUCTION PERMITS

Residential/Driveway Approach, Urban (curbed)	\$100.00
Residential Driveway Approach, Rural (shoulder/ditch)	\$100.00
Shared Residential Driveway Approach	\$100.00
Commercial Driveway Approach	\$200.00
Private Road Approach (each)	\$200.00
Farm Field Driveway Approach	\$100.00
Temporary Construction Driveway Approach	\$100.00
Overhead Utility Installation	\$250.00
Underground Utility Installation	\$250.00
Open Cut Road Crossings	\$500.00
Bore Road Crossings	\$300.00
Vegetation Removal/Trimming (Trees, Stumps, Brush, Limbs)	No Fee

### TRANSPORTATION PERMITS

Large Loads/Mobile Home/Single Move	\$200.00
Building & Special Load Move	\$100.00
Designated Hauling Route	\$200.00 (Plus \$100 per mile)
Solid Waste (Annual)	\$1,000.00 (Plus \$10 for each Truck)
Logging	\$200.00 per Job

### SPECIAL USE PERMITS

### ANNUAL BLANKET PERMITS

### NOTES AND PAYMENT

Permit Fees are to be paid when the original application for the permit is filed.

**Security** will be provided by the applicant, as determined by the Road Commission, to ensure proper construction and restoration in the right-of-way. **Security for Right-of-Way restoration** will be provided in the form of cash or check, and forms provided by the Road Commission are the **only** acceptable alternatives for utility permits.

**The applicant will be liable for any and all inspection fees, unless otherwise noted on the permit application. An invoice with an itemized statement will be generated for deficient accounts on a monthly basis. Any unexpended fund balance will be refunded following the completion of work. Non-payment of an invoice will result in suspension of the review process or a Stop Work Order during construction.**

**In the event the applicant does not properly repair damages, the applicant will be liable to pay a \$200 inspection fee plus the cost of any repairs.**
