## ORDINANCE NO. <u>06</u>-2025

## AN ORDINANCE ESTABLISHING THE PUBLIC DEFENDER COMMISSION GRANT FUND

WHEREAS, the Board of Commissioners of Clark County, Indiana (the "Board"), is the executive body of Clark County Government pursuant to the provisions of Ind. Code § 36-2-2-2; and,

WHEREAS, the Board is also the legislative body of Clark County Government pursuant to the provisions of Ind. Code § 36-1-2-9; and

WHEREAS, the Clark County Public Defender's Office has been awarded a Public Defender Commission on Court-Appointed Attorney Grant for calendar year 2025 for the purpose of misdemeanor data collection; and

WHEREAS, as a requirement of the said Grant Award, a local, non-reverting, fund for the purpose of receipting, holding and expending allowable program receipts and expenses must be established; and

**WHEREAS**, the Board now desires to establish the "Public Defender Commission Grant Fund" for the above-stated purpose.

## NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE CLARK COUNTY COMMISSIONERS, AS FOLLOWS:

- 1. Establishment: The Public Defender Commission Grant Fund (the "Fund"), which is assigned Fund Number 9152, is hereby established as a non-reverting fund to be administered and maintained by the Clark County Auditor.
- 2. Deposits into the Fund: Only monies from the said program (and any matching grant funds, if applicable) shall be deposited into the Fund.
- 3. Purposes of Permitted Expenditures from the Fund: Money in the Fund shall be used only to pay those expenses allowed under the said grant program.
- **4. Term of Fund:** The term of existence of the Fund shall be perpetual until the Fund is fully expended or terminated by subsequent ordinance adopted by the Board.
- 5. Auditor's Duty to Manage the Fund: The Clark County Auditor is hereby directed to maintain and manage accurate accounting information regarding the receipts, expenditures, and balances of the Fund as well as any reporting requirements pursuant

to Indiana law.
