ORDINANCE NO. <u>26</u> - 2011

AN ORDINANCE ESTABLISHING AUTHORITY FOR THE CLARK COUNTY AUDITOR TO AUTOMATICALLY TRANSFER FUNDS ON A MONTHLY BASIS FROM CERTAIN OFFICES AND DEPARTMENTS TO COVER EMPLOYEE GROUP HEALTH INSURANCE COSTS NOT OTHERWISE PAYABLE FROM THE COUNTY GENERAL FUND.

WHEREAS, this Board has traditionally contracted with insurance providers for policies for employee group health insurance, which policies cover employees (and, in certain circumstances, their spouses and dependents) whose salaries and benefits are paid from the County General Fund as well as other County funds; and,

WHEREAS, the Clark County Auditor has had to perform a significant amount of otherwise unnecessary paperwork in order to bill departments not supported by the County General Fund for their employee group health insurance costs; and,

WHEREAS, this Board now adopts this Ordinance in order to establish authority for the Clark County Auditor to make transfers for payment of such costs on a monthly basis without necessity of generating an invoice or receiving payment from such departments for such costs.

NOW, THEREFORE, BE IT ORDAINED by this Board as follows:

1. Commencing January 1, 2012, the Clark County Auditor shall have the authority to effect automatic transfers on a monthly basis for employee group health insurance costs from County departments and offices that are not funded by the County

General Fund. All such transfers shall be receipted into Fund 5201 (Health Insurance Fund).

- 2. The Clark County Auditor shall report all such automatic transfers to affected office holders, department heads, and this Board on a not less than monthly basis by utilizing the form attached hereto as Exhibit "A".
- 3. This Ordinance shall not diminish or impair the obligation of the Clark County Auditor to comply with all requirements of the Indiana State Board of Accounts in making the automatic transfers authorized by this Ordinance.
- 4. This Ordinance shall be in full force and effect upon its adoption by the Board.
