


EXHIBIT "A"

DESCRIPTION OF A 0.324-ACRE TRACT

Being a part of Block No. 115 in the City of Jeffersonville and a part of the 100-foot right-of-way of Broadway, a portion of which was vacated by Ordinance No. 05-OR-51 as recorded in Instrument 200519839, being further described as follows:

Commencing at the southwest corner of said Block No. 115; thence along the east right-of-way line of Broadway, North 04°16'31" East, 15.00 feet to the True Point of Beginning;

Thence North 85°18'51" West, 50.00 feet to the centerline of Broadway; thence along said centerline, North 04°16'31" East, 176.86 feet; thence South 60°07'39" East, 100.82 feet; thence South 04°16'31" West, 133.96 feet to the north line of an existing Perpetual Easement to State of Indiana by Deed Record Book 210, Page 106; thence along said north line, North 85°18'51" West, 40.93 feet to the True Point of Beginning.

Containing 0.324 acres, more or less, and being subject to any easements and rights-of-ways of record.

Also, a Temporary Construction Easement as shown on Exhibit "B", containing 0.553 acres, more or less, which shall revert back to the owner upon completion of construction.

The above described 0.324-acre tract that is a part of the land conveyed to The Board of Clark Memorial Hospital by Instrument 200718508, including a part of the easthalf of the Broadway right-of-way, a portion of which was vacated by Ordinance 05-OR-51.
