ORDINANCE NO. 31 -2016

AN ORDINANCE ADOPTING THE LANGUAGE OF THE BOARD OF CLARK COUNTY RECYCLING'S RESOLUTION 2016-009

WHEREAS, this Board of Commissioners of Clark County, Indiana (this "Board"), is the executive body of Clark County government pursuant to the provisions of Ind. Code § 36-2-2-2; and,

WHEREAS, this Board is also the legislative body of Clark County government pursuant to the provisions of Ind. Code § 36-1-2-9; and,

WHEREAS, The Board of Clark County Recycling (hereinafter the "District") is a duly authorized and established District pursuant to Ind. Code §13-11-2-7 and § 13-21-3 *et seq*; and,

WHEREAS, the District may adopt resolutions which must be adopted by this Board pursuant to Ind Code § 13-21-3-12(a)(17); and

WHEREAS, the District desires to extend the Clark County Recycling program to the unincorporated areas of the County via recycling bins/dumpsters strategically placed throughout the county and has thereby passed Resolution 2016-009, which also establishes a Seventeen Dollar (\$17.00) annual fee to be invoiced on each spring tax roll starting in 2017;

NOW, THEREFORE, BE IT ORDAINED by this Board of Clark County Commissioners as follows:

1. That the language of Resolution 2016-099 of the Board of Clark County Recycling as attached hereto as Exhibit "A", is hereby adopted and approved.

2. This Ordinance shall be in full force and effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of this Board.



RESOLUTION NO. 2016 – 009

**A RESOLUTION INSTITUTING A RECYCLING FEE FOR THE UNINCORPORATED
AREAS OF CLARK COUNTY, INDIANA**

WHEREAS, the Board of Clark County Recycling (hereinafter this "District") is a duly-authorized and established District pursuant to Ind. Code § 13-11-2-7 and Ind. Code § 13-21-3 *et seq.*; and,

WHEREAS, pursuant to Ind. Code § 13-21-3-12(a)(17), this District may adopt resolutions, but the resolution is not effective in a municipality unless the municipality adopts the language of the resolution by ordinance or resolution; and,

WHEREAS, currently this District assesses a \$34 per year fee for curbside recycling for the City of Jeffersonville, Town of Clarksville, and Town of Sellersburg through an interlocal agreement; and,

WHEREAS, numerous of residents in the unincorporated area of Clark County, Indiana have requested access to closer recycling or curbside recycling; and,

WHEREAS, this District now desires to extend the Clark County Recycling program to the unincorporated area via recycling bins/dumpster strategically placed throughout the county; and,

WHEREAS, in order to fund said extension, this District must assess a fee to service the unincorporated area.

NOW THEREFORE BE IT RESOLVED by this Board of Clark County Recycling that the following fees are assessed on certain properties classifications within the unincorporated areas of Clark County, Indiana:

1. Fees. The Board of Clark County Recycling shall assess a yearly \$17 fee to be invoiced only on the spring tax roll starting in 2017. Said fee is not paid in arrears and is billed each year.
2. Property Classifications. Single family dwellings, multi-family dwellings, structure and/or dwelling units, mobile homes, manufactured homes and other lots with improvements.
3. This Resolution shall be in full force and effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of this Board.
