

**Minutes of the Meeting
of the Clark County Drainage Board
Clark County, Indiana**

May 21, 2019

The Clark County Drainage Board met in Regular Session on May 21, 2019 in Room 418 of the Clark County Government Building, Jeffersonville, Indiana at 5:00pm. Present at the meeting were President Mike Killen, Vice president Jack Coffman, Member Tim Hunt, Ex-officio non-voting member Clark County Surveyor David Blankenkober, non-voting advisor Clark County Engineer Brian Dixon, attorney Ron Culler, and secretary Talaina Taff.

For the first order of business, Mr. Hunt moved to accept the minutes of the April 16, 2019 meeting as submitted. Mr. Coffman seconded the motion. Motion passed unanimously.

In the next order of business, the Board reviewed the drainage complaint from **Anthony Elzy – 6417 Shungate Road, Jeffersonville**. County surveyor, David Blankenkober reported that there is a blockage of a natural surface water course. Mr. Coffman moved that attorney Ron Culler contact adjoining property owner, Kevin Adamson to notify of a hearing to be held at the June 18, 2019 Drainage Board meeting concerning this drainage issue. Mr. Hunt seconded the motion. Motion passed unanimously.

In the next order of business, the Board reviewed the drainage complaint from **Nicholas Esposito – 13214 Starlight Court, Memphis**. Mr. Dixon gave report and discussion followed. This is a private property issue. The Board took no action.

In the next order of business, the Board reviewed the drainage complaint from **Danny Collins (filing for his father, Wayne Collins) – 20407 Charlestown-Bethlehem Road, Charlestown**. Mr. Dixon gave report and discussion followed. This is a private property issue. The Board took no action.

In the next order of business, the Board reviewed the drainage complaint from **Bobbie Goforth – 4827 Salem Noble Road, Jeffersonville**. **Daniel Frantz (grandson)** was present at meeting. Mr. Dixon gave report and discussion followed. This is a private property issue. The Board took no action.

In the next order of business, the Board reviewed the drainage complaint from **Geraldine Noble – 3903 Halls Corner Road, Underwood**. Issue was referred to the County Highway department. The Board took no action.

In the next order of business, the Board reviewed the drainage complaint from **Jerry Copas – 2012 Perry Crossing Road, Sellersburg**. Mr. Dixon gave report and discussion followed. This is a private property issue. The Board took no action.

In the next order of business, the Board reviewed the drainage complaint from **Kyle Wanke – 9100 Falcon Ridge, Sellersburg**. After discussion, Mr. Coffman moved that Mr. Culler and the Planning & Zoning attorney confer on a letter to be drafted and sent to the Homeowner's Association of Tanner Estates advising of the situation of fences / blockages in some drainage easements. Mr. Hunt seconded the motion. Motion passed unanimously.

In the next order of business, **Nathan Grimes** with **Renaissance Design Build, Inc.** presented plans for **Mini Storage System – Deerfield Crossing, Memphis.** After discussion, Mr. Hunt moved to approve the plans as submitted. Mr. Coffman seconded the motion. Motion passed unanimously.

In the next order of business, the Board and **Rob Huckaby, Qk4** discussed the Storm water user fee / tax. Mr. Killen moved that the Drainage board send, with a recommendation, to the Commissioners that they adopt a drainage fee ordinance to be added to the tax assessment bills and that Mr. Culler, Mr. Huckaby, and county attorney Scott Lewis work together to draft the ordinance. Mr. Hunt seconded the motion. Motion passed unanimously.

In the next order of business, Mr. Hunt moved to approve the budget report as submitted. Mr. Coffman seconded the motion. Motion passed unanimously.

In the next order of business, Mr. Coffman moved to approve the claims as submitted. Mr. Hunt seconded the motion. Motion passed unanimously. The claims were as follows:
