

Minutes of the Meeting
of the Clark County Drainage Board
Clark County, Indiana

February 16, 2016

The Clark County Drainage Board met in Regular Session on February 16, 2016 in Room 418 of the Clark County Government Building, Jeffersonville, Indiana at 5:00pm. Present at the meeting were President Mike Killen, Vice President Jack Coffman, Member Les Kavanaugh, Ex-officio non-voting member Clark County Surveyor David Blankenkober, attorney Bob Bottorff, and secretary Talaina Taff.

For the first order of business, Mr. Coffman moved to accept the minutes of the January 12, 2016 meeting as submitted. Mr. Kavanaugh seconded the motion. Motion passed unanimously.

In the next order of business, the Board reviewed drainage complaints with Mr. Blankenkober. **Danny Collins, 4705 Blue Ridge Road, Charlestown** – After review and discussion, the Board determined that this is not a Drainage Board issue. Mr. Kavanaugh moved that the Board transfer this issue to County Engineer Brian Dixon and the County Highway department. Mr. Coffman seconded the motion. Motion passed unanimously. **Zach Pedigo, 11526 Valley Forge, Sellersburg** – After review and discussion, the Board will obtain drainage plans for Yorktown Park Section 6 from Gary Brinkworth's office. Mr. Kavanaugh moved to table this complaint until further review of said drainage plans. Mr. Coffman seconded the motion. Motion passed unanimously. **Marilyn Taylor, 2223 Honeysuckle, Sellersburg** – After review and discussion, Mr. Kavanaugh moved that attorney Bob Bottorff write a letter to builder/developer Roger Schmitt to remedy this drainage issue. Mr. Coffman seconded the motion. Motion passed unanimously.

In the next order of business, **Nathan Grimes** presented plans for **Country Lake Christian Retreat Center – Worship Center and Dormitory, 815 Country Lake Road, Underwood**. Mr. Kavanaugh moved to approve the plans. Mr. Coffman seconded the motion. Motion passed unanimously.

In the next order of business, the status of MS4 project was discussed with the Board.

In the next order of business, secretary Talaina Taff gave financial report.

In the next order of business, Mr. Coffman moved to approve the claims as submitted. Mr. Kavanaugh seconded the motion. Motion passed unanimously. The claims were as follows:


- **XBE, Inc. - \$364.75 – EPSON copier ink**

There being no further business before the Board, on motion made, seconded, and passed, the meeting was adjourned at 6:10pm.


