The Clark County Drainage Board met in Regular Session on May 17, 2016 in Room 418 of the Clark County Government Building, Jeffersonville, Indiana at 5:00pm. For the first order of business, Mr. Kavanaugh moved to accept the minutes of the April 19, 2016 meeting as submitted. Mr. Coffman seconded the motion. Motion passed unanimously.

In the next order of business, Mr. Blankenbeker advised the Board to accept the \$950.00 proposal from Hart's Surveying and Engineering LLC. and hire said company to perform surveying services in Henryville regarding **William Fehribach** complaint from April 19, 2016 meeting. In the next order of business, the Board reviewed drainage complaints from **Tom Lumley Enterprises**, **13615 Bluelick Road**, **Memphis** and **Robin Hargis**, **15405 Hwy 31**, **Memphis**.
